Basic criteria for achieving this selection are:

- 4. Agreement to commit the necessary time and effort to complete the program and participate in the following year's program development and implementation.

All applicants must be at least 21 years of age to participate in the program.

TUITION

The cost of the program is \$1,500 per participant for members of the Indian River County Chamber of Commerce, program sponsors and host. Non-member tuition is \$1,800. This is payable no later than January 6, 2025, and covers the cost of orientation, meals and beverages, materials, transportation, and graduation ceremony for the nine-month program. The tuition may be tax deductible as a business expense; consult your tax advisor.

ATTENDANCE REQUIREMENT

The scheduled sessions fall on the 2nd Thursday of each month. To successfully complete the Indian River County Leadership Program your participation is required at all sessions. One absence may be granted for extenuating circumstances.
